#### Free Transportation for COVID-19 Vaccinations

In February 2021 we began providing free transportation to COVID-19 vaccination appointments and clinics to encourage our community to get vaccinated as well as make sure everyone has access to a vaccine. This program was offered to anyone who needed transportation, regardless of previous public transit use, and will continue to be provided into 2022 as long as

vaccinations and a need for transportation also continue. This free service was made possible due to support from the Washington County Board of Commissioners, the SW PA Area Agency on Aging, and the PA Department of Transportation.

Published a Transit 101 video to YouTube to offer digital training in place of in-person sessions.


Installed on-board public Wi-Fi on fixed route buses to increase rider commuting amenities.







Provided over 700 free trips for COVID-19 vaccinations using shared ride service & fixed route bus passes.




Extended the Local A & Local Saturday routes to provide service to Bellmead, the Senior Center, & TRPIL.




Began offering a Summer Youth Bus Pass to attract a new demographic of school-aged riders.


# Fixed Route Ridership




### Fixed Route Operating Expenses




### Fixed Route Operating Funds




Shared Ride Ridership
