Seniors 65+ ride free with a PA Transit ID Card.

Children 11 and under ride free when accompanied by an adult rider.

Half Fare cards are available for eligible riders.

**TRANSFERS** are free unless transferring to a higher fare bus route. The transfer must occur within 4 hours of receipt of the transfer ticket from the driver and cannot be used for a free ride on the route from which the transfer was secured. When transferring onto a higher fare bus route, the passenger must pay the "up value" upon boarding the connecting bus.

Download the Freedom Transit mobile app to buy fares or passes and validate them once on board the bus. The app allows you to explore routes, plan trips, and save addresses.

The Freedom Transit app is on the App Store and the Google Play Store.

- Download the app.
- Select Fares tab.
- Pick the fare or pass and complete the purchase.

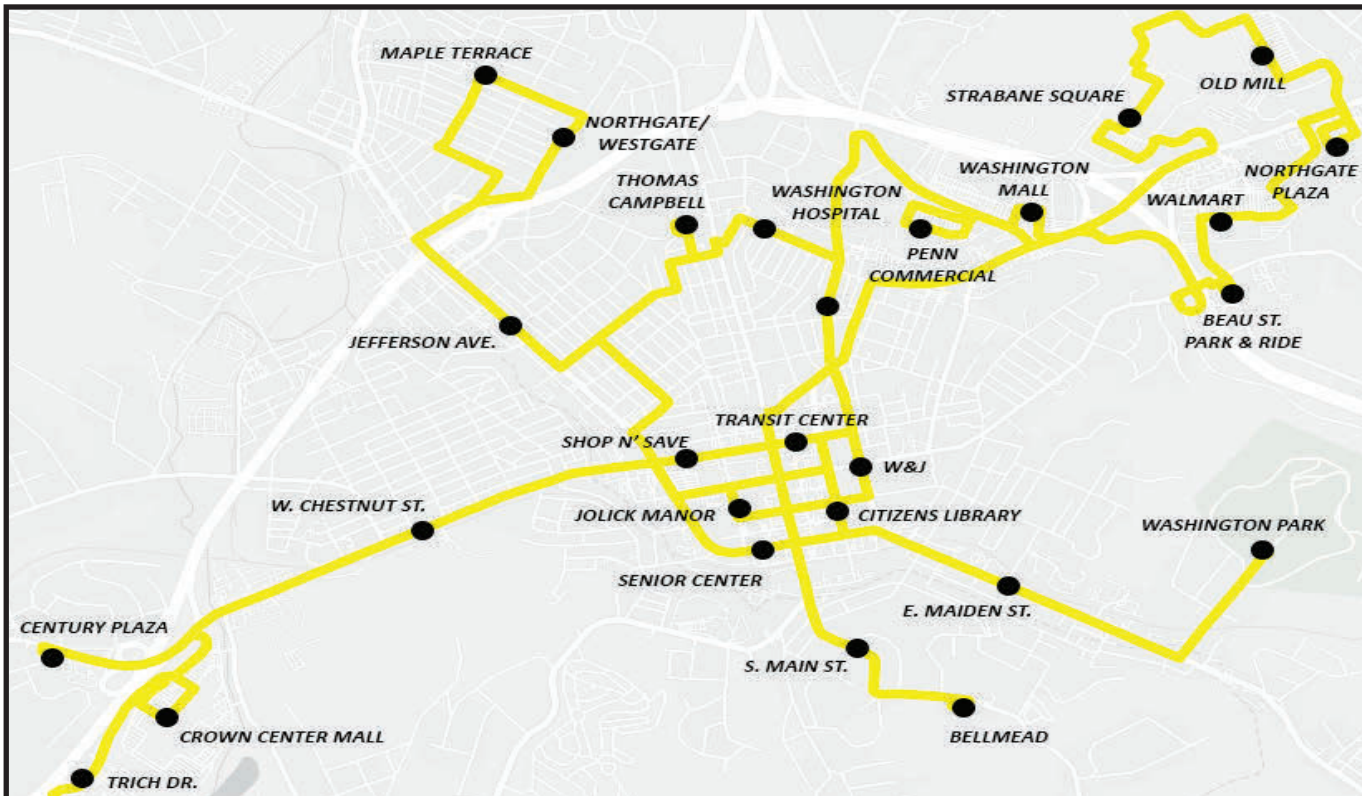
