Seniors 65+ ride free with a PA Transit ID Card.

Children 11 and under ride free when accompanied by an adult rider.

Half Fare cards are available for eligible riders.

TRANSFERS are free unless transferring to a higher fare bus route. The transfer must occur within 4 hours of receipt of the transfer ticket from the driver and cannot be used for a free ride on the route from which the transfer was secured. When transferring onto a higher fare bus route, the passenger must pay the "up value" upon boarding the connecting bus.

**Freedom Transit** mobile app to buy fares or passes and validate them once on board the bus. The app allows you to explore routes, plan trips, and save addresses.
